

Mobility and Streetcar Ridership



- √ 16 in design








# BUS SERVICE MODIFICATIONS (APRIL 2024)

### **ROUTE 192—OLD DIXIE/TARA BLVD**

- ✓ Proposed shift from Old Dixie Hwy to Old Dixie Rd, between CW Grant Pkwy and Central Ave
- ✓ Addresses requests to serve
  Southpoint Industrial Park, Home Lodge
  Extended Stay
- ✓ Feasible on completion of railroad underpass on CW Grant Pkwy
- ✓ Route 193 would continue to serve Old Dixie Hwy



### **ROUTE 195—FOREST PARKWAY**

- ✓ Expands end-of-line loop to serve the Gillem Logistics Center via Metcalf Rd, Anvil Block Rd
- ✓ Establishes service while considering staffing resources and routing limitations
- ✓ Provides service to growing employment area, but may extend travel time for some current passengers
- ✓ Service would operate on current hourly schedule (5:30 AM – 12:30 AM weekdays, 6:30 AM - 12:30 AM weekends)



# MARTA 2040 Capital Expansion



## JUSTICE CENTER TRANSIT HUB UPDATE

## **Project Status:**

- ✓ Final design on track for completion in Spring 2024
- Ongoing coordination with Clayton County to address short- and long-term safety between hub and jail visitation area
- ✓ Fencing between the transit hub and the Justice Center is currently in design. It has the potential to be released as an early package

**Projected Completion: 2026** 







### **MULTI-PURPOSE OPERATIONS & MAINTENANCE FACILITY UPDATE**

### **Project Status:**

- ✓ Demolition bid package to be released Q1 2024
- ✓ Scheduling a groundbreaking for Q2 2024
- √ 60% Plans for new facility are complete
- √ 100% Plans will be completed Q2 2024



**Projected Completion:** August 2029




## MARTA RAPID SOUTHLAKE (BRT) UPDATE

Proposed airport terminus study complete. This alternative will save 12 minutes roundtrip from Norman Drive to connect directly to both the heavy rail system <u>and</u> the airport.

### **Next Steps:**

- ✓ Final designer solicitation underway
- ✓ NEPA studies underway
- Open house for public comment in March
- ✓ Board of Commissioners Resolution
- ✓ LPA amendment to MARTA Board




